

Stallion Breeding Contract

I, _____, agree to take a nomination to the stallion, Staccato/ Sandhills Sensation*, for the season 20____ and agree to the conditions set hereunder.

CONDITIONS

- 1. The service fee for Staccato/ Sandhills Sensation* is \$1650 (GST inc).
- 2. Artificial Insemination is available and full payment of service fee is required before semen is collected and sent. Vet collection fee will be charged by the attending veterinarian and transport of semen cost is also required before semen is sent.
- 3. A non-refundable deposit of \$330.00 (inc GST) is required with the Contract. The balance of the fee is required within seven (7) days of a 45-day positive pregnancy test or when the mare leaves the premises of Craig and Prue Barrett, whichever comes first.
- 4. Please note that no Contract is said to have been made until Craig and Prue Barrett receive the completed Contract and Payment.
- 5. For the entitlement of any refund of service fees, Craig and Prue Barrett must be in receipt of a Veterinarian Certificate within fifty (50) days of the last service, stating that the mare is not in foal. (Please condition 2).
- 6. Due to (a) Numbers of visiting, (b) Nervous Mares, (c) Chronic infections, (d) Foal proud mares, (e) Safety considerations, or (f) any other circumstance deemed appropriate, stud management reserves the right to use Artificial Insemination techniques without prior owner consultation in extenuating circumstances. This is a very gentle way to get a mare in foal and many difficult breeders will happily conceive using this method. Any extra costs will be borne by the mare owner.
- 7. In order to minimise stallion use, maximise stallion fertility and maximise mare conception, stud management reserves the right to direct policy on Follicle Testing, Pregnancy Testing and consequent drug therapy, such as Antibiotics, Prostaglandin, Oxytocin, Ovuplant and Flushes. At all times, the minimising of costs and maximising of successful conception without compromising the mare s wellbeing will be the essence of invoking this condition. The mare owner will meet all costs.
- 8. A new contract is required at the beginning of each season for each mare.
- 9. Costs are as follows: (GST inc) Agistment per day \$30 (separate paddock, full feed) Drenching \$25 (as required) Hoof Trim \$80 (as required) Dentist \$77 (as required)
- 10. In all cases Veterinary Charges are the responsibility of the owner of the mare. The stud management has the right to call the Veterinarian at any time, for any reason, without consulting the owners, in the event of circumstances deemed urgent. Otherwise, all reasonable efforts will be made to keep owners abreast of developments.
- 11. The stud will take all reasonable care, but shall not be liable to the owner in the event of the death of the horse(s) or in the same receiving any injury or suffering any illnesses howsoever arising.
- 12. There is no foal guarantee, however Craig and Prue Barrett are very interested in mare owners getting a live, healthy foal on the ground. In the event of bad luck, the mare slipping, foaling difficulties or some other disappointing circumstance, the stud should be notified immediately and in most cases a minimised fee retry can be negotiated.

13. Should the mare owner fail to have a veterinarian examine the pregnancy for twins or abortions at or before eighteen (18) days after insemination, and between forty (40) and sixty (60) days after conception Craig and Prue Barrett the free- return will be void. It is the responsibility of the mare owner to assist in maintaining the pregnancy with regular veterinary checks and to maintain the mares optimum health during the pregnancy.

14. All accounts must be paid in full before service certificates will be issued.
